#### CALL TO ORDER, WELCOME AND INTRODUCTIONS

- President Lyon called the meeting to order at 9:05 AM.
- Delmarva811's Mission Statement was reviewed by the President.
- The meeting agenda was presented.
- J. Lyon outlined the name and logo change from Miss Utility of Delmarva to Delmarva811. He also mentioned there is real-time data being presented on the website for inbound ticket volume on the dashboard. The data refreshes every hour.
- J. Lyon played a video from Miller Pipeline about calling 811 before excavating.
- Introductions were made by all attendees. Virtual attendees were asked to enter name, company name, & contact information in the Teams chat.
- Meeting attendance included 29 participants in person and virtually.
- A motion to approve the meeting minutes dated July 18, 2024 was made by R. Lewis. The motion was seconded by B. Ebaugh. The motion carried.

#### ITICnxt – DIGITAL TICKET PROCESSING (PROFESSIONAL EXCAVATORS)

 ITIC 2.0 has been retired as of 4/1/2024. J. Arroyo gave presentation/overview. Delmarva811 provides monthly ITICnxt virtual trainings. J. Arroyo provided dates for upcoming virtual trainings opportunities (9/5, 10/3 & 11/7 at 2:00 PM). Excavators are encouraged to use online system. Visit www.Delmarva811.com to pre-register for these training classes and review the many resources offered. There is a Google registration. Register a minimum of two business days ahead for these free training. Interactive online training is available through the website along with several YouTube videos on how to use the system. The demo/sandbox site is still available. There is a link directly to the calendar to know when upcoming trainings are occurring. Online resources are available 24/7. Reach out to S. ### EXCAVATOR/MEMBER/LOCATING CONCERNS

- R. DiChristofaro from BCCI asked for update about saw cutting. No current update was provided.
- R. DiChristofaro also brought up new large water replacement projects coming in the fall. The room discussed various ways to ease the burden to the locators and make BCCI's work more efficient.
- B. Peters brought up a project where Delmarva Power hit a DelDOT storm sewer and was billed for it. Storm sewers are not utilities and not required to be marked, but how can you be responsible if they aren't marked. Is there any traction for getting storm sewer required to join? M. Ruddo said we could bring it up at the OCC Users Group next month.
- J. Sapp asked for a contact with a manager or safety professional from Simple Fiber.
- B. Cahall brought up a contractor in Talbot County abusing the 811-system calling in emergencies for drain line for flooding. M. Ruddo stated that you could report to the authority and fines could be administered.
- DelDOT mowing is damaging locates. DelDOT will not avoid flags or marks.
- R. Ross brought up an event in Cambridge, MD where he was performing a locate audit where a Beazer builder superintendent stated Chesapeake Utilities 3<sup>rd</sup> party gas main installer installed a gas line in conflict with the foundation of a building. The superintendent told the contractor to change the location of the line installed the day it was being put in the ground (change was not documented or approved by Chesapeake Utilities). Beazer wanted Chesapeake Utilities to pay for the relocation, when it was Beazer who asked for it to be moved in the first place. This has caused delays and expenses for both parties.

#### **NEW BUSINESS**

- M. Ruddo Miss Utility of Delmarva 30 second commercials 3 times this week during "The Direction" which is a fishing show.
- W. Ericksen brought up some statistics. 90 total reports YTD through August 9<sup>th</sup>. 51 incidents were excavation issues, 16 were one call issues, and 19 were locating related issues. They sent out 29 warning letters and 9 NOPVs with fines totaling \$9,350. They also have advertisements on the internet and radio. In December they will be having their tri-annual safety conversation meeting. The NOPVs and warning letters appear to be focused on natural gas damages. Not all smaller damages for other utilities have to get reported. C. Myers asked if the PSC would be focusing on addressing damages and trends for other utilities as well. T. Bullock brought up that no matter what gets damaged, the behaviors are similar by excavators that could cause unsafe situations.
- W. Ericksen stated they received the 2024 report from PHMSA stating the DE PSC enforcement was deemed adequate.

There being no other business brought before the board or committee, a motion was made to adjourn the meeting by B. Ebaugh. It was seconded by R. Lewis. The motion carried. The meeting adjourned at 10:27 AM.

The next hybrid General Membership meeting date is planned for September 19, 2024 at 9:00 AM.
