## CALL TO ORDER, WELCOME AND INTRODUCTIONS

- President Lyon called the meeting to order at 9:05 AM.
- Delmarva811's Mission Statement was reviewed by the President.
- The meeting agenda was presented.
- J. Lyon outlined the name and logo change from Miss Utility of Delmarva to Delmarva811. He also mentioned there is real-time data being presented on the website for inbound ticket volume on the dashboard. The data refreshes every hour.
- Introductions were made by all attendees. Virtual attendees were asked to enter name, company name, & contact information in the Teams chat.
- Meeting attendance included 29 participants in person and virtually.

  - PSC tracks damage reports by county in Delaware. Volume is largest in NCC, and then Sussex and Kent. Kent has seen an uptick as new housing develops.
    - YTD 84 warning letters and 29 penalty letters. \$14,500 in civil penalties this year so far.
  - Partnering with the fire schools in each county to provide training in local areas.

    - Triannual safety seminar is going to be early December. Videos will be posted on YouTube and listed on our PSC website. The goal is to educate all stakeholders who will need to respond to a damage.
    - \$1000 / inch fines for natural gas/propane damages are still up to change per the consent agreement
    - Fines will be sent to excavators and locators.
    - Warning letters will be sent out to contractors who are putting in emergency tickets that are not emergencies.
